## Dear CFCI Families,

We would like to thank you again for your support and feedback after Friday's dismissal delay. As you may know, there was an incident which created the need for us to bring students and staff quickly & safely back into the building. This was done following our safety protocols that our students and staff are familiar with. As parents/guardians, we know that feeling confident in the safety of your child at school is extremely important. Our goal is to keep our students and staff safe and be prepared for an emergency or crisis at a moments notice. To prevent risking the safety of your child and their classmates, it is important for parents to understand what the school and local law enforcement require of them during emergency situations.. Because of this, it is our responsibility to provide timely information on the status of your child's safety. We have an emergency communication system in place that notifies families via email, voice and text messages. Our plan includes informing parents and guardians of any unusual situation that demands that we follow our safety protocols. We will continue to work with local officials to insure that our protocols are working. We appreciate our faculty & staff's quick and efficient response on Friday. As always, we will reflect on what went right and where we can improve. Thank you, again, for your patience, support and feedback.


## Our Constitutional Convention - Friday, September 30th

Over the past six weeks of school, our teachers have been working in our classrooms to develop rules and expectations that help our students learn and live together. This week, we will finalize our schoolwide rules that have been developed by representatives from each of the classes. After sharing their classroom rules last week, students worked together to decide the schoolwide rules that would best align with their classroom rules and give all students a sense of belonging. We look forward to creating visible artwork that represents our rules to hang in the hallway of our school. The rules will be presented to the entire school at the end of the week. Everyone will sign the rules as a way of committing to the schoolwide rules that have been created. Engaging all of students in the rule-setting process helps them take ownership of the rules. Engaging all of the adults emphasizes for the children the significance of their work. Together, we are creating a calmer, happier place for learning.

Teacher and students collaborate to generate rules that allow all class members




### Framing the rules in the positive

Teachers find over and over that this investment of time and effort is well worth the payoff of calm, productive, and joyful classrooms.



### The excitement builds as we make final plans to order our playground equipment!





The Playground will be funded through ESSER Funds PRC 181 - for the betterment of outdoor educational experiences that mitigate close contact and social distancing.




Upper Playground plus volleyball and tetherball areas.

In this activity students built and modified a gear train to increase torque and speed.




**7th and 8th Grade STEAM Class with Ms. Cress**

## Weekly Wellness

Happy Fall!

School is in full swing. With changing seasons and crisp air right around the corner, sniffles, sneezes and sore throats become a common complaint.

Please do not send cough drops and throat lozenges to school with your students as these are considered medication. We are required to have a Physician's Authorization for Medication at School form on file for each student requiring medication



(prescription and over-the-counter medications.) If your student requires medication at school, the form is available on our website under the Enrollment section.

Hard candies such as Lifesavers and Werther's Originals, can be sent in and used in moderation in place of cough drops and throat lozenges.

Remember, proper hand washing is the easiest and most effective way to prevent the spread of germs! While hand sanitizer works in a pinch, good old soap and water is best. When should you wash your hands? Before and after you eat, after you blow your nose or cover your cough/sneeze with your hands, after you use the bathroom or any time your hands are sticky or dirty.

### **Arrival and Dismissal Update!**

Thank you to everyone for your cooperation and patience as we begin the school year and take time to analyze our traffic procedures. We are asking that you take a few minutes to look over the updated arrival and dismissal protocols. In the next two weeks we will begin our Safety Patrol - Middle Grades Students who volunteer to help with morning arrival. This should help with getting our littlest ones out of the car and make for a smoother transition. We appreciate everyone's help in ensuring our #1 Goal: The safe arrival and dismissal of our students! If you have any questions or concerns, please do not hesitate to reach out to Ben Pierce or Ben Rose. Thank you in advance.

#### **Arrival**

- Please try to arrive between 7:45am and 8am. We put the late sign out at 8:05. If you arrive after 8:05am, you must park, and come into the office to sign your children in. They are considered TARDY at this point.
- Please pull all the way up in the line - do not leave gaps between cars.
- Please have your child ready to get out on the sidewalk side only.
- If your child needs additional assistance, please let one of the adults on duty know and they will assist. Please do not get out of your vehicle as it stops the flow of traffic for others and can be dangerous.
- If your child is having difficulty leaving the vehicle, please pull all the way up so that it does not impeded the arrival of other cars.
- Once you arrive at the sidewalk, please have your child get out - do not wait and then pull up closer so that your child does not have to walk as far. This takes twice as much time and impedes our ability to get everyone out safely and efficiently.

#### **Dismissal**

##### **Lower Lot Dismissal**

- Please have your car seats arranged so that children can get in from the sidewalk side.
- Please do not get out of your car. Cars sometimes pass on the left and it makes for a dangerous situation.
- Please be patient and do not drive around other cars if at all possible. The flow of traffic is important.
- If your child requires a second call, we will ask that you pull down to Wonder Way and wait for them to be escorted down to you by an adult.

- If your student forgets something, please go down to Wonder Way and wait for them. Determine if what they are missing is necessary or can wait until tomorrow.

Please let anyone who is picking your child up know what the procedures are for arrival and dismissal. Thank you for your help and cooperation with our procedures. We know that drop off and pick up can be trying and we appreciate your support.


